RULES & REGULATIONS:

DAMAGES/SECURITY:

CMRVT shall not be liable for any damages, whether direct, indirect, general, special, consequential or otherwise to the Vendor, its agents and employees, or by another Vendor. If products are not securely fastened to the display, we suggest you remove them when the exhibit is not occupied.

CMRVT will provide security. Security is not responsible for watching vendors' booths. They are not responsible for loss or damage to vendor merchandise, possessions or vehicles.

SET UP:

Set up hours are: Friday July 18th only. All vendors must be set up and ready before the gates open at 4:00pm Friday July 18th. Show hours are: Friday 4:00pm-12:00am (live music). Saturday, 9:00am-1:00am (live music). All Vendor booths must be open by 4:00pm on Friday and can choose to stay open as late as they want but must be open until at least 9:00pm. It would be behoove food vendors to stay open until the live music is over but is not required. Alcohol vendors are the only vendors required to close by 2:00am. Saturday July 20th all vendors must be open by 9:00am

We cannot allow people to set up or break down during the rally.

Take down hours: Sunday Only. There will be no dismantling of booths allowed during show hours.

RESERVATION:

Checks or money order should be made payable to Crossroads Motorcycle Rally of Vermont (CMRVT). All checks must be accompanied by this signed Vendor Agreement, vendor license, and proof of insurance (certificate of liability). This should all be mailed to CMRVT 329 US Route 2 Waterbury Vermont 05676. No refunds will be given once accepted. If a Vendor cancels their contract CMRVT has the right to sell the Vendors spot.

Reservation is not made until the contract and payment are received.

You must supply your own tent, table, extension cords, water supply hoses and anything else you will need to vend your product.

Each Vendor will receive a listing on the website, four (4) weekend admission passes with full access to the events and night camping with parking. **If vendors need more than four admission passes they will need to purchase them.**

SALES TAX LICENSE:

Each Vendor is responsible for charging state sales tax and paying the appropriate state.

ALCOHOL:

There will be NO alcohol sold or consumed anywhere except for in the "Beer Hall" located in the event area.

CLEAN UP:

All vendors must use supplied garbage containers. On Sunday by 12:00pm their sites must be clean. Vendor is responsible for getting trash into supplied dumpster. Site will be checked before vendor is released.

ANIMALS:

If you choose to bring an animal to the rally they are required to be on a leash at all times. You can only have your animal at your vendor space and in the camping area. We cannot allow you to walk around the vending area with your animal. If at any time your animal is not on a leash you will be asked to leave with no refund. As the owner you are also asked to clean up after your animal.
